#### MADHYA PRADESH BILL No. 15 OF 2022

## THE MADHYA PRADESH NIJI VISHWAVIDYALAYA (STHAPANA AVAM SANCHALAN) SANSHODHAN VIDHEYAK, 2022

A Bill further to amend the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007.

Be it enacted by the Madhya Pradesh Legislature in the Seventy-third year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhiniyam, 2022.

Amendment of Schedule.

2 In Schedule to the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007), after serial number 40 and entries relating thereto, the following serial numbers and entries relating thereto shall be added, namely:—

3.(1) The Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Dwitiya Repeal and Sanshodhan Adhyadesh, 2022 (No. 2 of 2022) is hereby repealed.

(2) Notwithstanding the repeal of the said Ordinance, anything done or any action taken under the said Ordinance, shall be deemed to have been done or taken under the corresponding provision of this Act.

#### STATEMENT OF OBJECTS AND REASONS

In Section 5 of the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007), it is provided that the Regulatory Commission constituted under the Act shall evaluate the proposal of establishment of Private University in the State. In the light of the said provision, the Regulatory Commission has recommended to establish the Private Universities, namely, Prestige University Indore, Times University Bhopal (now the changed name is Shubham University Bhopal), Dr.Preeti Global University Shivpuri and LNCT Vidhyapeeth University Indore. In the light of Section 6 of the said Act, the State Government has issued letters of intent to the sponsoring bodies of the Universities, with regard to establishment of the said Universities. Section 9 of the said Act provides that after being satisfied on considering the report submitted by the Regulatory Commission, Private University shall be established by incorporating the name and description thereof in the Schedule to the said Act.

- 2. As the matter was urgent and the Legislative Assembly was not in session, the Madhya Pradesh Niji Vishwavidyalaya (SthapanaAvamSanchalan) Dwitiya SanshodhanAdhyadesh, 2022 (No. 2 of 2022)was promulgated for the purpose. It is now proposed to replace the said Ordinance by an Act of the State Legislature with modification as to establishment of four other private universities namely, Amaltas University, Dewas, Aryavart University, Sehore, Vikrant University, Gwalior and Gyanveer University, Sagar following the same aforesaid procedure specified in the Act.
- 3. Hence this Bill.
